Conditions:

1. Staff serving in Main Office and other Sub-Offices except PAO (Ors) MLI, Belgaum who have been sanctioned Motorcycle/Scooter/Moped Advance may prefer the claim by submitting Contingent Bill to Main Office. In respect of Staff serving in the Office of PAO (Ors) MLI Belgaum, the advance may be drawn locally.

2. If the purchase price of conveyance is less than the amount of advance sanctioned, the excess amount sanctioned may be refunded to the Govt. forthwith.

3. The vehicle should be purchased within one month from the date of drawal of advance and the cash receipt, registered documents of the vehicle duly registered in the name of loanee (without hypothecation to any financial institutions) and insurance policy should be produced duly attested by the concerned officer to Main Office, within one month from the date of purchase of vehicle or within two months from the date of drawal of the advance whichever is earlier. Failing, which the full amount together with penal interest should be refunded to Government.

4. No application seeking extension of time for purchasing a vehicle will be entertained nor permission will be given for purchase of second hand vehicle after the drawal of advance sanctioned.

5. The amount of advance in respect of the individuals is recoverable in equal instalments as shown against their names and recovery of interest in equal monthly instalments followed by the recovery of advance.

6. If the individuals are intending to purchase Motor cycle/scooter/Moped through a person having official dealing prior sanction of the competent authority is required to be obtained under 18(3) of CCS(C) Rules.

7. It may please be ensured by the Drawing and Disbursing Officers before making payment that no amount is outstanding against bicycle advance from the individuals who have been sanctioned Scooter Advance.

8. The advance is to be drawn and paid only on production of proof of availability of vehicle, where advance booking is involved.

9. Date of payment of scooter advance made to the above named staff members may be intimated to M.O. to link the relevant records.

10. In case, the individuals are NOT WILLING to draw the advance, this office may please be intimated by return of post.

11. It may please be ensured by the Drawing and Disbursing officer before making payment that the individuals will meet the balance of amount by making their own arrangement incase the cost of Vehicle is more than the advance sanctioned. Applications seeking permission to buy second hand vehicle stating that amount of advance is not sufficient will not be entertained
