TERMS AND CONDITIONS FOR PROVISION OF SECURITY SERVICES TO THE PRINCIPAL
CONTROLLER OF DEFENCE ACCOUNTS, BANGALORE AND ITS SUB- OFFICES.

1. PCDA, Bangalore require services of security guard One shift at PCDA Bangalore and round the clock security coverage at SI.No.2,3 and 4 of office buildings mentioned above.
2. The services are required for a period of one year initially from the date of acceptance of the Quotation/Contract Agreement by the Competent authority and may be further extended on required basis.
3. Security guards provided should perform their duties as allocated by the officer in charge concerned, for all the 7 days in a week including Sundays & Holidays. In case of their absence/proceeding on leave, alternate arrangements should be made well in advance under intimation to the offices concerned to perform the duties without fail and without any additional cost.
4. All the security guards detailed by your firm should wear proper uniform provided at the cost of your firm only.
5. Field Officers of your agency should visit periodically with more frequency and supervise the performance of security guards posted and suggest precautionary measures if any apart from the security checks as ordered by the offices.
6. Your agency will be held responsible to make good the losses/damages if any occur to the building/Govt. Property, during the period of their duties
7. Security Guards should strictly maintain the timings of their shifts and disciplines.
8. The presence and the timings of the security guards will be recorded and watched through an attendance register maintained for this purpose.
9. The payment of the service charges will be made in arrears on monthly basis in the following month through ECS/EFT. Bank account details may be furnished
10. The contract agreement will be terminated if any of the conditions are violated or the

services of the security guards are not satisfactory.

11. The rate quoted should be for each security guard with a minimum 8 hours duty a day for all the seven days of the week on monthly basis.

12. In case of any eventualities, the liability/responsibility for the security guards regarding payment of compensation squarely lies on the firms.

13. With in a week of placement of order, firm shall furnish a security deposit equal to 5% of the order value in favour of the PCDA, Bangalore in the form of a bank guarantee or DD valid till one month from the date of placement of orders.

14. Sealed quotation should be submitted duly enclosed with the following documents, viz. EPF No., Registration No, ESI Registration No., Service Tax code No., Income tax Pan No., Labour Deptt. License Professional Tax No. and Company Registration No. , List of clients etc.

15. The Quotations which are not enclosed with the above documents will be liable to be rejected.
