Sub: Grant of Entry Pay to address the anomaly of pay between the directly recruited Section Officers (A/C) and the Departmentally appointed/promoted Section Officers (A/C) now AAO of the Organized Accounts Department.

There was demand from promotee SO(A)/AAOs for Grant of Entry Pay to departmentally promoted SO(A)/AAO citing reference to Office of the CGA, New Delhi OM dated 13.02.2018 and CAT(PB)New Delhi order dated 06.03.2017 in OA No. 100/1456/2017.

2. As such, the matter was taken up through MoD(Fin) DAD (Coord) with Ministry of Finance/Department of Expenditure and Ministry of Finance, Department of Expenditure has agreed to extend similar benefits to the AAOs of Defence Accounts Department (DAD) vide their I.D. dated 14.05.2018 as granted to the AAOs under Controller General of Accounts (CGA) vide their OM dated 13.02.2018.

3. In view of approval of Ministry of Finance, Department of Expenditure the promotee SO(A)/AAOs may be allowed minimum Entry Pay as applicable to direct recruits under 6<sup>th</sup> CPC w.e.f. 01.01.2006 in the Grade Pay of Rs. 4800/- i.e. Rs. 18150/- (B.P 13350 + G.P 4800) from the date of their appointment on promotion to the post. The re-fixation of pay would be admissible from the date of promotion in each of the individual cases. Further, they shall also be entitled to arrears arising out of pay fixation. But, no interest on payment of arrears will be admissible.
