He/she should not be an employee of the Central or any State Government or local body and should not own and occupy any other shop in Bangalore.**

The prospective bidder can inspect the shop premises on any working day between 11 AM to 3 PM starting from 01/01/2018 to 21/01/2018.

The desiring persons may apply for allotment of shop No. 7 in a formal application as per the proforma enclosed in sealed cover, so as to reach this office on or before 21<sup>st</sup> January 2018 by 03.00 PM duly Super scribing the cover as "ALLOTMENT OF SHOP NO. 7".
