(Pay - I) dated 23-04-99, No.13/02/2017.Estt(Pay-I) dated 27th July 2017 and clarification No. 2 of Govt. of India, Min. of Fin. F NO. 1/1/2008-IC dated 13-09-08 and the options may be sent to AN PAY III Sn of this office.

An Undertaking may also be obtained from the individual(s) to the effect that in the event of any erroneous promotion noticed at later stage, he/she would be liable to refund the differences of Pay and Allowances to the department.
