Subject: Recommendations of the Committee to suggest measures for streamlining  
implementation of NPS

Sir,

In pursuance of the decision of the Government, the Department of Financial Services had constituted a Committee to suggest measures for streamlining implementation of National Pension System under the Chairmanship of Secretary, DoP&PW. The Committee has since submitted its report.

2. With regard to delay in crediting of contribution into NPS architecture, the Committee has made the following recommendations:

"In case there is delay in crediting of contribution into NPS architecture beyond the prescribed timeline due to factors not attributable to the concerned employee, the amount may be credited to the NPS account of the employee along with the interest for the delayed period. The rate of interest for this purpose would be the same as applicable to GPF from time to time for the period of delay up to 31.03.2018. The interest would be compounded annually. For the delays after 31.03.2018, the rate of interest would be the average rate of return in Tier-I of NPS during the previous year. Such rate of interest based on the average returns would be notified by PFRDA from time to time."

In order to enable this Department to consider issue of general orders to give effect to the recommendations in so far as the issue of making up the delayed payment based on the applicable GPF rate of interest during the period of delay up to 31.03.2018 is concerned, in an appropriate and procedurally correct way, it is requested that necessary inputs and suggestions may be given urgently so that the proposed order does not lead to any practical difficulties on the part of pension accounting organizations.
