Subject : Modified Assured Career Progression Scheme (MACPs):
Accounts Officer.

All Sub-Offices under the Organisation and Sections in Main Office are requested to forward the names of eligible Accounts Officers due for grant of financial benefit under MACPS (due up to March 2021). Names of eligible Accounts Officers who fulfill the criteria under the 6th CPC and corresponding pay matrix in 7th CPC and completed 10/20/30 years of service during the period upto March 2021 only to be forwarded. Also names of those who have been stagnated in the same post/grade continuously for more than 10 years in the same Grade Pay and corresponding pay matrix in the 7th CPC together with left over cases if any which could not be considered due to one reason or the other **may be forwarded by 04/09/2020** positively for onward transmission to HQrs Office for further examination and necessary action.

Those Officers who have already earned three promotions and stagnated for more than ten years in the same grade pay are not eligible for financial upgradation under MACPS.

It may be ensured that no names of eligible officers are left out. NIL REPORT is also required.
