**MOST URGENT**

It has been decided by the Deptt. of Financial Services (DFS), Ministry of Finance, Govt. of India, to quantify pending NPS contributions which are not yet remitted to the Trustee Bank for investments. In this regard, please provide following information year wise regarding such non-remitted NPS contributions as on 31<sup>st</sup> December 2017.

1. Employees who have joined on or after 01-01-2004 not yet registered under NPS and their contributions are also not deducted by their nodal offices for remittance.
2. Employees who have joined on or after 01-01-2004 not yet registered under NPS and their contributions are deducted but not remitted to Trustee Bank for investment.
3. Employees who have joined on or after 01-01-2004 and currently registered under NPS and their contributions are not deducted by their nodal offices for remittance.
4. Employees who have joined on or after 01-01-2004 and currently registered under NPS and their contributions are deducted but not remitted to Trustee Bank for investment.
5. Employees who are registered under NPS but their contributions are remitted irregularly or stopped currently.
