Subject: Revision of Bhutan Compensatory Allowance (BCA) for Armed Forces Officers and Personnel Below Officer Rank serving with Indian Military Training Team (IMTRAT) and Border Road Project Dantak in Bhutan.

Sir,

I am directed to refer to this Ministry's letter No.4(1)/2005/D(Pay/Services) dated 3rd March, 2019 on the above subject and to forward herewith a copy of Ministry of External Affairs letter No. E.IV/235/3/2006 dated 1st April, 2019 regarding revision of Bhutan Compensatory Allowance (BCA) with effect from 01.04.2017 and 01.04.2018. The provisions of the said letter will mutatis-mutandis be applicable to Defence Service Officers and Personnel Below Officer Rank serving with Indian Military Training Team (IMTRAT) and Border Road Project Dantak in Bhutan.

2. The recovery of depression of 6% for officers and 4% for PBORs from Bhutan Compensatory Allowance payable to IMTRAT personnel in lieu of free facilities as laid down in this Ministry's letter No. 1(9)/2000/D(Pay/Services) dated 20th September, 2005 stands removed w.e.f. 11.2.2019 as per this Ministry's letter No. PC 1(9)/2000/D(Pay/Services) dated 22nd March, 2019.

2. This issues with the concurrence of Finance Division of this Ministry vide their Dy.No. 4(30)/96/AG/Vol-I/168-PA dated 20-07-2019.
