Promotion to the post of Sr. Auditor was released vide HQrs. Office letter No. AN/XI/11060/2017/Vol.I dated 11.04.2017, wherein 18 Auditors were promoted to the post of Sr. Auditor and 22 Auditors were given promotion subject to clearance of mandatory two weeks training.

HQrs. vide their letter No. AN/XI/11060/Promotion/Corrs/2017 dated 30.08.2017 has called for promotion/antedating cases of Auditors (Roster NO. 792 to 1726) arising due to promotion of Sr. Auditors released on 11.04.2017 as under .

- (i) **Direct recruited Auditors of CGL 2012 batch.**
- (ii) **Promotee Auditors who have been promoted between 01-04-2013 to 31-03-2014.**
- (iii) **Compassionate appointment cases who have joined before 21-09-2013.**

**It is requested to forward Cases of Promotion/Antedation , as mentioned above wherein applicant is senior, completed probation and has also successfully completed two weeks training as stipulated in RR(Recruitment Rules) to the post of Sr. Auditor. It would be also intimated that the names of Auditors who have not successfully completed two weeks training or who have not completed probation, should not be considered for Antedation/Promotion.**

Names of eligible Auditors serving in your Office/section who fulfill the above criteria, may be forwarded to this office in the Proforma may be downloaded from Website of HQrs Office/PCDA Bangalore. It must be ensured that all columns of the proforma are complete.

The information may be forwarded to this office positively by **15.09.2017** so as to enable this office to furnish the same after adjudication by Board to HQrs. Office within the stipulated date, i.e., 29.09.2017.

'NIL' reports are also required.


All local offices/sections are requested to hand over the reports by hand directly to AN III Section and outstation offices are requested to send the reports by FAX without fail.
