Dear Minister,

As you are aware, a number of programmes under execution in the country are named after national leaders, particularly, Smt. Indira Gandhi and Shri Rajiv Gandhi, former Prime Ministers of India.

2. This practice has become widespread and indiscriminate. This reduces the value of identifying programmes with national figures particularly as implementation and impact of many of these programmes is not always as it ought to be. As such, many of them do not merit such association.

3. I have, therefore, been directed to convey that, in the light of what is stated above, there is need to be sparing and selective in associating names of national leaders with such programmes to prevent proliferation of such nomenclature.
