Sub : Election of new DADERWA members for DAD Residential Complex,  
Someshwarapura Extn., Ulsoor, Bengaluru.

On completion of tenure of two years of the existing members of the DAD Resident Welfare Assn, the following Managing Committee for Defence Accounts Department Employees Resident Welfare Association, DAD Residential Complex, Someshwarapura Extn., Ulsoor, Bengaluru is required to be elected.

- i) President (One post)
- ii) Vice President (One post)
- iii) Secretary (One post)
- iv) Treasurer (One post)
- v) Members (Three posts)
  - (a) Cultural & Sports activities
  - (b) Upkeep of maintenance, Security & Environment
  - (c) Lady Member-Representative of Women and Children

02. The terms of the elected office bearers and members shall be two years (Block of two financial years) and they shall not hold any of these offices for more than 02 terms continuously i.e. 4 years.

03. All office bearers and members of the Managing/Executive Committee shall be elected in the general elections to be held by secret ballots on 24.09.2022.
04. DAD employees residing at DAD residential complex will be eligible to seek office in the Managing /Executive Committee.
05. The election shall be conducted by Shri D P Sinha who is appointed as Returning Officer.
06. The Returning Officer would be given the copies of voters' list (clearly indicating voter number) along with necessary material i.e. stationery/blank nomination forms/requisite funds etc. by the Managing Committee to carry out activities connected with the conducting of elections.
07. Members (including Associate Members), whose subscription and other dues are not in arrears up to 31<sup>st</sup> of March of the year preceding the election year, shall be eligible to vote.
08. Those who are interested in contesting election shall submit their nomination forms, duly proposed, seconded and accepted by the contestant member for a particular office, to the Returning Officer by 19.09.2022. (No person can hold more than one office at a time and, therefore, will be eligible to contest only for one post).
