SUB: Promotion of Clerks to the grade of Auditor for the vacancy year 2023

HQrs office vide their letter no AN-XI/11401/DPC/2023/Clerk to Adr dated **12.08.2022** has requested to convene a DPC to adjudicate those clerk-cum-typist who have rendered minimum of thirteen years regular service in the grade as on 01.01.2023 and for those who are holding the feeder post of clerk-cum-typists for 8 years on regular basis as on the 26th day of September 2009 for consideration of their promotion to the grade of Auditor.


Further, it is mentioned in the said letter that maximum relaxation of eligibility service delegated in the Administrative Ministry/ Department upto 3 months for those would complete eligibility service prescribed in the RRs between 1st January and 31st March 2023 being 1st January 2023 the crucial date of eligibility.

In view of the above, the names of all eligible/left over/ carry over cases of previous year of clerks may be forwarded in the Proforma enclosed (Annexure 'C') duly attested by officer-in-charge positively by **31.08.2021** so as to enable this office to furnish the same after adjudication by DPC to HQrs.
