

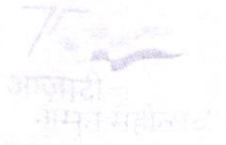

Further, it has also been decided by the Competent Authority to make the "Har Ghar Tiranga" campaign a big success, Indian National Flags may be hoisted in all residential Complexes, Offices, Training institutions, Transit/Guest houses and Hostel Accommodations during the Independence Week from 11th -17th August 2022.
